This is a full body clear lacquer for 'filled pore' look suitable for most wooden substrates giving a hard and resistant surface with good chemical and mechanical properties. The product can be used either with a sealer or as a multicoat and has good vertical spray properties without sagging, excellent clarity and air release. DM1302 contains UV protection for reduced yellowing and is a good choice for marine furnishing. Not suitable for fast production lines.
